Medical Fee: £5.00 per competitor

The competition will be held in the Andrews Bowen All Weather Arena. All fences will knock down. First phase will be six to eight coloured fences. The second phase will be seven to ten knock down rustic fences. Each phase has a time limit. If time limit is exceeded in the Show jumping Phase time faults will be given at 1 fault per second. After the first phase the competitor will go straight on to the second phase, even if they have faults, (but not if eliminated). For Cross Country Phase an Optimum time will be given – combination closest to this time with the least faults throughout the whole course wins.

Fences not exceeding 70cm

Fences not exceeding 80cm
Show Jumping speed 325 mpm Cross country speed 350 mpm

Class 3 - 90 cm

Fences not exceeding 90cm.

Show Jumping speed 325 mpm Cross country speed 350 mpm

Class 4 - 100 cm

Fences not exceeding 100cm
Show Jumping speed 325 mpm Cross Country speed 375 mpm

Class 5 - 110 cm

Fences not exceeding 1.10m.

Show Jumping speed 325 mpm Cross Country speed 375 mpm

Sunday 20th March

Open to horses and ponies Qualifiers for NPS Arena Eventing Challenge take place on Sunday only

Class 6 - 70 cm

Fences not exceeding 70cm
Show Jumping speed 325 mpm Cross country speed 350 mpm

Class 7 - 80 cm

Fences not exceeding 80cm
Show Jumping speed 325 mpm Cross country speed 350 mpm

Class 8 – 90 cm

Fences not exceeding 90cm.

Show Jumping speed 325 mpm Cross country speed 350 mpm

Competitors must be at least in the year of their 12th birthday Ponies competing must be 138cms or above. Saturday classes only

Class 9 - 100 cm

Class 10 - 110 cm

Fences not exceeding 1.10m.

Show Jumping speed 325 mpm Cross Country speed 375 mpm

Classes 6,7 & 8 are qualifiers for the NPS/ ANTHONY EVANS ARENA EVENTING CHALLENGE FINAL.

4 Faults for fence knock down both phases
4 Faults for 1st refusal
8 Faults for 2nd refusal
3 Refusals across entire course – ELIMINATION
Error of Course - ELIMINATION
Fall of rider or horse – ELIMINATION

GENERAL REGULATIONS

Entries

- 1. Entries must be made online via: https://equilive.uk Paper and telephone entries will not be accepted.
- 2. Entries for all classes will close on 13th March at 23:59. The organising committee reserves the right to close entries prior to this date if the total entries exceed the maximum number for the day.
- 3. Entries: Entry fee per class £16.00 First Aid fee per rider per day £5.00
- 4. Saturday Only: All classes are open to horses and ponies over 138cm and to Riders aged 12 and over
- 5. Sunday: No restrictions for classes 1,2 & 3.
- 6. Sunday: Classes 4 & 5 open to horses and ponies over 138cm and to riders aged 12 years and over
- 7. Horse/Pony Combinations may compete in 2 consecutive classes only.
- 8. If numbers permit in any class, pony rider combinations will be judged with separate results.
- 9. Withdrawn entries before start lists are release with be refunded minus a £5 admin fee per class
- 10. In the event classes are oversubscribed a waiting list will be put in place

Arrival and Departure

- 11. Entry will be via Ingliston Road following signs to the airport from the A8. Further details will be given closer to the time.
- 12. On arrival at the Showground, people must follow all directions given to them by the show officials.
- **13.** Please ensure that you do not muck out your horsebox onto the Car Park. Take all litter home with you.

Collecting Ring

- 14. People not specifically authorised to enter the Collecting Ring by the organising committee will not be permitted entry.
- 15. Anyone found to be entering the Collecting Ring who has not been specifically authorised may be asked to leave the Showground.
- 16. The number of Horses in the Collecting Ring at one time will be limited for safety purposes at all times.

Start Times

- 17. Start times will be allocated in groups of five, drawn order must be adhere to.
- 18. Start Times will be posted online.
- 19. The organising committee reserve the right to alter the Start Times in certain circumstances such as the fall of a rider. The organising committee will make every effort to inform Riders of any changes.

<u>Prizes</u>

- 20. Rosettes will be awarded to 1st 6th place
- 21. Prizes in kind will be awarded 1st to 3rd place.
- 22. All prize giving's will be made with riders dismounted

Cancellation

23. In the event of cancellation, your entry will be refunded, less £5 per class admin fee. Refunds will not be given after times have been published.

Data Collection

Our legal basis for processing personal data in film footage and photographs is legitimate interests. Legitimate interests means that we need to process the personal data to fulfil our objectives, we believe it will not adversely affect you and we think you would expect it. We collect CCTV images of those visiting the Royal Highland Centre (including those attending the Royal Highland Show and other events).

Young People's data

For young people volunteering or competing at the Royal Highland Show we collect and store your name, address, date of birth, email address, occupation, telephone and mobile numbers and financial information as appropriate for the purposes of effectively facilitating your volunteering and administering the competition and informing you of future volunteering and competition opportunities.

Use of Personal Data

We only use your personal data as permitted under the EU General Data Protection Regulation (the GDPR), the Data Protection Act 2018 and the Privacy of Electronic Communication Regulation 2003.

46.2 We use the personal data you provide to fulfil our contract with you and keep you informed about important information regarding the Royal Highland Show such as key dates and health and safety information.

Third party processors

We may sometimes ask third parties to process personal data on our behalf. This may include the transfer of personal data outside the EEA. We will always ensure that any such processors treat your data securely, in accordance with our terms and requirements under the GDPR. We do not sell, trade or rent your personal data to third parties outwith the RHASS Group and will only share it with organisations we work with in line with legal requirements. We may share aggregated and anonymous demographic information (not linked to any personally identifiable information) with our business partners.

We share your personal data with Breed Societies to which we are required to submit entries to be checked for validity and eligibility. Results will also be sent to those bodies so that qualification and awards may be verified.

Retention of Personal Data

We retain personal data properly and securely to enable us to meet legal requirements, business needs and to evidence agreements or events where required. Records containing personal data are retained in accordance with our data retention and disposal policy and procedure.
