## TERMS AND CONDITIONS

### 1.0 Definition

The Term 'Company' used throughout these Terms and Conditions shall refer to PRATT BROS (Exhibitions) LTD. The term 'Customer' refers to the person or Company placing orders.

Completion of our Application Form shall be accepted by the Company as an order placed by the Customer, their Agent or a Sub Contractor employed by them and to which these conditions apply.

### 2.0 Electrical Supply Details

The electrical supplies shall be based on-  
230 volts, Single Phase A.C. 50 Hertz  
400 volts, Three Phase A.C. 50 Hertz

*It should be noted the Electricity/Generation Supply Company have ultimate control of the electricity supplies to the Showground and surrounding areas do not guarantee the integrity of their service. Therefore, our Company are governed by their Conditions and are unable to accept any responsibility for variations or loss of supply.*

### 3.0 Load Details

The Customer must not exceed the current rating of equipment that they have stated in their Application. If in doubt please contact our Technical advisors in advance at our Main Office who will gladly assist. If power supplies require upgrading, the difference in cost must be paid at time of change along with administration fee of £35.00 excl. VAT. No refund if downgraded supply will be given however administration fee will still apply.

### 4.0 Disclaimer of Liability to Exhibitors

Save for death, or personal injury caused by breach of its duty the Royal Highland & Agricultural Society of Scotland and We as the official Electrical Contractor will not be responsible for death, injury, disease, damage or loss caused to any Exhibitor or Consumer of Electricity or to his or her servant or an agent or to any animal, article, plant, machinery or thing of whatever nature brought on to the Showground or Exhibition Hall, by the said Exhibitor or Consumer whatever cause death, injury, disease damage or loss arises. (save as aforesaid) the Exhibitor or Consumer shall indemnify the Society and Pratt Bros against all claims, damages and expenses whatsoever in any way arising out of the presence of the Exhibitor or Consumer, his servants, agents, exhibits, vehicles or equipment on the Showground or Exhibition Hall and shall assume full responsibility therefore.

Acceptance of the foregoing provisions shall be a condition of this Contract.

Exhibitors are advised to insure against Fire, Any Loss of power including refrigerated/frozen food and other appropriate risks not only as regards to their own property but also against any Third Party Claims

All materials used in the installation are on hire for the period of the Show only and Exhibitors will be held responsible for any such materials etc, which are damaged or missing during or on completion of the Show, fair wear and tear excepted.

Our Application Form is in accordance with a scale of charges submitted to and approved by the Royal Highland & Agricultural Society of Scotland for the Show.

Submission of a completed Application Form by the Customer is understood to be made, subject to the Royal Highland & Agricultural Society of Scotland's Trade Stand Regulations.

### 5.0 Health and Safety

As a Company, Pratt Bros (Exhibitions) Ltd operate a comprehensive Health & Safety Policy. Copies of our Safety Policy are available to view at our Main Office.

The Customer may be asked to provide a copy of their own Health & Safety procedures on request, together with any Risk Assessments.

NOTE: Existing Services

The Customer and / or their Sub Contractor using "high sided" vehicles must observe and take adequate measures to avoid overhead cables throughout the Showground.

The RHASS Estates Dept operates a Permit to Work system for the erection of marquees and structures and this must be adhered to avoid Contact with underground services

The Company reserve the right to charge the Customer for any damage caused by them or their Sub Contractors.

### 6.0 Electrical Installations and Conditions

a) The Company reserves the right to interrupt / disconnect any Electricity Supply or part of any circuit at any time without notice. Customers shall safeguard any essential equipment including IT Systems and shall provide their own Uninterruptible Power Systems that they deem necessary.

b) The Customer must ensure their own equipment and appliances have been regularly tested and certified for use

The Customer shall provide PAT records full risk assessment and certification for each appliance.

The Company reserve the right to ensure the Customer removes any appliances deemed unsuitable for use

c) The Customer shall ensure that the installation of exhibition displays and / or Mobile Units is carried out by competent qualified personnel fully conversant with the current IEE wiring regulations (BS7671: latest amendment)

Mobile Units must be provided with any up to date Electrical Condition Report including a Schedule of Test Results.

Where multiple electrical items are installed by the customers appointed electrical contractor a BS7909 Certificate for Temporary Electrical Installations must be provided to us. We can provide the mains characteristics and test results to assist with completion

It is the Customers responsibility to ensure all adequate methods of protection are provided against electric shock namely by use of RCD's not exceeding 30mA

d) The use of Generators within the Showground is strictly forbidden

### 7.0 Payment

Payment should accompany the completed Application Form, which must be received no later than 29<sup>th</sup> May 2020, thereafter supplies cannot be guaranteed and surcharges will apply. Payments received after 29<sup>th</sup> May 2020 may be subject to an administration fee of £20 ex VAT.

Payment made by Commercial credit card will incur a 1.75% charge. Cheques will not be accepted after 5th June 2020

8.0 The Customer must notify the Company's Main Office of any defective or missing items of hired equipment as soon as possible, but in any case by 12 noon on the opening day of the Event, failing which no refunds or rebates will be considered.
