

List Party Comp Terms and Conditions

1. Introduction

1.1 These terms and conditions apply to the List Party X RHC prize draw competition for Edinburgh Summer Session concert tickets organized by Royal Highland Centre.

1.2 By entering the competition, participants agree to be bound by these terms and conditions.

2. Eligibility

2.1 The competition is open to participants of aged 18 years or over.

2.2 Proof of age and residency may be required.

3. Entry Period

3.1 The competition will run from 9pm on the 31st of July til 1am 1st of August. Entries received after the closing date will not be accepted.

4. How to Enter

4.1 To enter the competition, participants must enter their email into the Social Jungle 360 degrees camera screen.

4.2 Only one entry per person is permitted this way. Sharing and tagging on social media will count as extra entries.

5. The Prize

5.1 The prize is two tickets to either Ocean Colour Scene on the 17th of August 2024 at the Royal Highland Centre.

5.2 The prize is non-exchangeable, and non-transferable, and no cash alternatives will be offered.

5.3 The Royal Highland Centre reserves the right to substitute the prize with another prize of equal or greater value if circumstances make it necessary to do so.

6. Winner Selection and Notification

6.1 The winner will be chosen by random draw performed by a randomised selection software on a computer by the 9th of August.

6.2 The winner will be notified by email or telephone (using details provided at entry) within 7 days of the closing date.

6.3 If the winner does not respond to the Royal Highland Centre within 48 hours of being notified, the winner's prize will be forfeited, and we will be entitled to select another winner by the process described above.

7. Publicity

7.1 The winner agrees to the use of their name and image in any publicity material, as well as their entry.

7.2 Any personal data relating to the winner or any other entrants will be used solely by current UK data protection legislation and will not be disclosed to a third party without the entrant's prior consent.

8. General

8.1 The Royal Highland Centre reserves the right to cancel, suspend, or amend the competition and these terms and conditions where it becomes necessary to do so.

8.2 The decision of the Royal Highland Centre regarding any aspect of the competition is final and binding, and no correspondence will be entered into about it.

8.3 The competition and these terms and conditions will be governed by UK law, and entrants to the competition submit to the jurisdiction of the courts of the UK
